

**INEP-PLUS** is an online course, which introduces the key principles of Evidence-Based Substance Use Prevention. It includes:

- 12 thematic training sessions with online group discussions lasting 1 hour and 30 minutes each;
- FAD (accredited remote distance individual training) (INEP Charles University (CUNI) Prague.

**Who is it directed to?** INEP-PLUS is directed to professionals in the field of Prevention of Substance Use Disorders and Pathological Dependence who work in both the public and private social services. The professional target will be represented by health and social welfare staff as well as experts from the education and law-enforcement sectors who deal with the planning and carrying out of prevention activities.

- The course has a closed number of participants. The Maximum number of participants is 20. Only the first 20 will be admitted.
