
KORUS Oslo



- The Regional Drug and Alcohol Competence Center
 - Prevention, early intervention, treatment
 - Entire life course
 - Funded by the Norwegian Directorate of Health
- 1 of 7 regions covering Norway
- Population: 5,5 million
 - Oslo: ~750.000


Review of Prevention Systems (RePS)

- Tool for assessing prevention initatives' alignment with the UNODC/WHO International Standards of Drug Use Prevention.
 - At systemic and specific initiative levels.
- Aimed at enhancing international prevention efforts.
- Designed to promote evidence-based drug use prevention.




Pilot in Norway 2022/2023

- Two main questions:
 - What's the situation in Norway?
 - Can you adequately assess a country's prevention efforts using this tool?
- Review committee from August 2022:
 - UNODC
 - Ministry of Health and Care Services
 - KORUS



The Process

- ✓ Official kick-off in Oslo September 28th, 2022, at the conference "Alcohol and drug prevention in the Nordic countries" arranged by the Nordic Council of Ministers
- \checkmark Translation and digitalization of Annex 2 in October 2022.
- ✓ Testing of Annex 2 in November and December in Oslo
- ✓ Identification and on-boarding of regional operatives in January 2023
- ✓ Data collection from February May
- ✓ June September data analysis, translation, supplementary information and contextualization
- ✓ Report launch at the Ministry of Health and Care Services on **September 28th**, 2023



Data collection – two components (questionnaires)

Strategies (Annex 2):

Assessment of existing strategies' adherence to the standards.

Are they evidence based?

Are their characteristics associated with effective prevention (the standards)?

System (Annex 4)

Assessment of the system.

Does the system facilitate effective and evidence based prevention?


Questionnaire:

- Whats done?
- Who is the target group?
- Where is it done (setting & region)?
- Why is it done?
- Documentation regarding evaluation and implementation could be attached
- Distributed to key persons in the regions


Data collection:

- 99 questionnaires distributed
 - 87 (81%) answered
- 187 unique reports
 - **130** (74%) after screening


Annex 2 – Strategies by target group age




Annex 2 – Strategies by prevention level

Lessons learned

- KORUS-structure was vital
 - Relevant competence
 - Close to the service providers
 - Comprehensive knowledge of existing efforts at regional and national levels
- Bottom-up process
 - Representatives of respondents were involved in adaptation and testing of questionnaire
 - Dialogue with respondents before and during data collection and analysis
- Translation and digitalization of the questionnaire was a necessity
- Local representatives in the Review Committee was essential
 - Translating, supplementing, contextualizing and quality control during analysis

What now?

- We have an overview of current prevention efforts are we doing the right things?
- Educational and awareness-raising at local, regional and national levels
- Strategy providers are curious about their results and motivated to use effective strategies
- Adds momentum to the KORUSes efforts in promoting evidence based prevention
 - E.g.: National effort for EUPC integration
- Provides valuable information for the further development and implementation of RePS globally
- Translation of the pilot report and EUPC to Norwegian
