1.0 Executive Summary

This report details the successful execution of a three-day residential teacher training program on school-based drug prevention, branded as the "Shiksha" program. Held from July 29th to 31st, 2025, at the Sarvodaya Training Center in Chaththurukondan, Batticaloa, the program targeted appointed counseling teachers and ISAs from the Sammanthurai and Kalmunai educational zones. Out of 50 invited participants, 44 attended, demonstrating a strong commitment to addressing drug-related challenges within the school system. The program's effectiveness was validated by a significant increase in participant knowledge, as measured by a pre-test and post-test, and was further affirmed by highly positive feedback regarding the usefulness and practical applicability of the training modules.

2.0 Introduction

The rise of substance abuse, particularly among adolescents, presents a significant challenge to youth development and public health. Recognizing the pivotal role of educators in this context, the "Shiksha" program was designed to empower school-based personnel with the necessary knowledge and skills to implement effective drug prevention strategies. This training was a crucial step towards building a resilient and informed educational community capable of supporting students and mitigating the risks associated with drug use. By focusing on evidence-based practices and foundational counseling skills, the program aimed to create a network of peer prevention supporters among teachers who could act as primary agents of change within their schools.



3.0 Program Objectives

The key objectives of the "Shiksha" program were to:

- Provide a comprehensive introduction to evidence-based drug prevention methodologies.
- Enhance participants' understanding of adolescent psychology, development, and risk factors.
- Equip teachers with fundamental counseling skills to effectively communicate with and support students.
- Deepen knowledge of the science behind addiction to enable a more informed and empathetic approach.
- Explore learning and development theories relevant to implementing school-based interventions.
- Guide participants through the practical implementation cycle of a school-based drug prevention program, from planning to evaluation.



4.0 Participants and Logistics

The program was a residential, three-day event to ensure full immersion and continuity of learning. Fifty counseling teachers and ISAs from the Sammanthurai and Kalmunai zones were officially invited. A total of 44 teachers participated, showing a dedicated turnout despite the demanding schedule. The training was conducted entirely in Tamil, which facilitated a comfortable and effective learning environment for all participants, allowing for nuanced discussions and a deeper understanding of the complex topics covered.



5.0 Training Methodology and Curriculum

The "Shiksha" program's success was largely due to its well-designed and interactive training methodology. The facilitators employed a combination of instructional techniques to cater to different learning styles and ensure a dynamic and engaging experience for all participants.

5.1 Teaching Methods

The training utilized a hybrid approach that included:

- Lectures with Multimedia Presentations: Expert-led sessions were supported by visual aids, including slides, charts, and short videos, to illustrate complex concepts and data on drug prevention.
- **Group Work:** Participants were divided into smaller groups to collaborate on case studies, problem-solving exercises, and practical scenarios. This fostered peer learning and encouraged the application of theoretical knowledge to real-world situations.
- **Discussions:** Open forums and Q&A sessions were a core component, allowing teachers to share their experiences, raise concerns, and seek clarification from the resource persons. This created a highly interactive and participatory atmosphere.



5.2 Topics Covered

The curriculum was carefully structured to build from foundational knowledge to practical application. The following topics were covered over the three days:

- Evidence-Based Prevention Introduction: This module introduced the concept of data-driven prevention strategies, highlighting the importance of using scientifically validated methods rather than anecdotal or unproven approaches.
- What is Adolescence? This session focused on the unique psychological, social, and biological
 changes that occur during adolescence, providing teachers with a deeper understanding of the
 target demographic and their specific vulnerabilities.
- Basic Counselling Skills: Participants were trained in foundational communication skills, including active listening, empathetic responding, and non-judgmental questioning, which are essential for building trust with students.
- Science of Addiction: This module demystified addiction by explaining its neurobiological basis.
 It covered topics such as brain chemistry, tolerance, withdrawal, and the factors that contribute to dependence.
- Learning and Development Theories: The training connected developmental psychology to educational practice, helping teachers understand how student behavior, motivation, and learning are intertwined with drug prevention strategies.
- **Implementing Cycle:** The final module provided a practical framework for designing, executing, and evaluating a school-based drug prevention program, empowering teachers to become leaders in this area.



6.0 Resource Persons

The program benefited from the expertise of two highly qualified resource persons who led the sessions with passion and knowledge.

- **Mr. M.M.G.B.M. Rashad:** Assistant Drug Education and Information Officer, brought valuable experience and a practical perspective on drug prevention and education.
- Ms. Sheefa Ibrahim: Counselling Assistant, provided specialized insights into counseling techniques and student support, complementing the theoretical knowledge with hands-on skills.
 Their collaborative effort ensured that the program was both informative and highly relevant to the participants' roles.



7.0 Evaluation and Outcomes

The "Shiksha" program utilized both quantitative and qualitative methods to assess its impact. The results demonstrated a clear success in achieving its core objectives.

7.1 Quantitative Analysis

To measure the knowledge gain, a pre-test was administered at the beginning of the program and an identical post-test at its conclusion. The results were as follows:

• Average Pre-Test Score: 58%

• Average Post-Test Score: 78%

This **20-point increase** in the average score is a statistically significant indicator of the program's effectiveness in developing the participants' knowledge base. It provides compelling evidence that the training successfully transferred critical information and concepts to the attendees.

7.2 Qualitative Feedback

The feedback received from the participants was exceptionally positive. During the final session, teachers commented that "all the knowledge gained was very useful" and directly applicable to their work with students. The high level of engagement was further demonstrated by the fact that many participants asked "equations" (likely meant to be "questions") throughout the sessions, showing a keen interest in the material and a desire for deeper understanding. This level of inquiry is a strong qualitative indicator of a successful training program.



8.0 Conclusion and Recommendations

The "Shiksha" teacher training program was a resounding success. It not only fulfilled its objectives but also surpassed expectations by significantly improving the knowledge base of the participating teachers and motivating them to apply their new skills. The combination of expert resources, a well-rounded curriculum, and a dynamic teaching methodology created an ideal environment for professional development.

To build on this success and ensure the long-term sustainability of the program's impact, the following recommendations are made:

- 1. **Follow-up Sessions:** Organize a one-day refresher course or a follow-up meeting within six months to allow participants to share their experiences and address new challenges.
- 2. **Resource Dissemination:** Provide participants with additional resources, such as a digital library of drug prevention materials, case studies, and contact information for further support.
- 3. **Formal Network:** Facilitate the creation of a formal network or online group for the trained teachers to collaborate, share best practices, and provide ongoing peer support.

By taking these steps, the "Shiksha" program can evolve from a one-time training event into a cornerstone of a sustainable, school-based drug prevention framework for the Sammanthurai and Kalmunai zones.
